Sub: Grant of Provisional Affiliation for introduction of M.Ed Course with an intake of 25 seats from the session 2007-08.

Sir,

I am directed to inform you that the Inspection Committee which visited your College on 29-12-2007 to verify the availability of infrastructural facilities and other support system to run the M.Ed. Course has submitted the report which has been considered. On the basis of the report of the inspection committee duly considered by the Standing Affiliation Committee, the Vice-Chancellor has been pleased to grant conditional provisional affiliation for introduction of M.Ed. Course with an intake of 25 seats as allowed by the NCTE vide letter 32746 dated 26-11-2007 from the session 2007-08 as one time exception in compliance with the orders of the Hon'ble High Court for including your College for counselling of M.Ed Course with the stipulation that your College will recruit the teaching faculty (including Professor & Readers) through duly constituted Selection Committee in accordance with prescribed procedure in terms of the norms of the NCTE/University and shall make available infrastructural facilities upto 20.3.2008 besides fulfilling the deficiencies pointed out by the University Inspection Committee which are briefed as under:-

1. To furnish Faculty Rooms as per University/NCTE Norms.
2. To strengthen/enrich the College Library by purchasing surveys.

You are, therefore requested to complete the above shortcomings and send compliance of the same within given stipulated period i.e. upto 20.3.2008 to enable this office to take further necessary action. If your College is failed to send compliance of the above deficiencies, further action under the University Act, Statute & Ordinances shall be initiated against your College. A copy of the inspection report is also enclosed for the purpose. Your College is required to deposit the provisional affiliation fee of Rs. 2.00 lac. Accordingly you are requested to deposit the same to enable this office to include the name of your college in the M.Ed Counselling scheduled to be held w.e.f. 29.1.2008
